GDPR Information Notice

Kamet S.A., with its registered office in Reńska Wieś (47-208), ul. Reński Koniec 14, entered in the Register of Entrepreneurs of the National Court Register under KRS number 0000374967, whose files are kept by the District Court in Opole, 8th Commercial Division of the National Court Register, Tax Identification Number (NIP): 7491946930, REGON: 532408166, is the controller of personal data (the "Controller") in the form of: **the name and surname of the carrier's driver supplying** the Controller, the name of the transport company, the position held as a driver of the transport company, the vehicle registration number, the name of the supplier, and contact details (carrier's or supplier's e-mail address and the carrier driver's phone number).

These data have been obtained from the carrier or the Controller's supplier in the course of performing goods supply agreements for the purposes arising from such agreements, in particular for the purpose of identifying the driver by the Controller's security when announcing (booking) the delivery of goods and for the purpose of pursuing claims, i.e., respectively on the basis of Article 6(1)(b) or (f) of the GDPR.

Personal data are processed only for the period necessary to achieve the purposes of processing and will be deleted from the Controller's databases immediately after the completion of processing for the purposes indicated above, no later than until the expiry of limitation periods for obligations arising from supply agreements. For the purposes described above, personal data may be transferred to Kamet Inwestycje S.A., with its registered office in Reńska Wieś (KRS: 0000697043), to the Controller's physical security service, as well as to IT service providers supplying software used by the Controller, in particular e-mail services, as well as to forwarding companies, companies providing professional document disposal services, and insurance companies.

Providing personal data is necessary for the execution of the transport of the delivered goods. The Controller does not apply automated decision-making or profiling with regard to your data.

You have the right to request from the Controller easy access to your personal data, rectification, erasure or restriction of processing, as well as the right to object to processing and the right to data portability, as well as the right to lodge a complaint with the competent supervisory authority responsible for personal data protection.
