GDPR B2B Information Notice

Kamet S.A., with its registered office in Reńska Wieś (47-208), ul. Reński Koniec 14, entered in the Register of Entrepreneurs of the National Court Register under KRS number 0000374967, whose documentation is kept by the District Court in Opole, 8th Commercial Division of the National Court Register, Tax ID (NIP): 7491946930, REGON: 532408166, is the controller of personal data (Data Controller, DC) in the scope of:

1. first name, last name, company name, registered office address, NIP, REGON, bank account number as well as residential address and PESEL number (disclosed in contracts), as well as contact details (mailing address, email address, telephone and fax numbers) of the DC's contractors and suppliers. The above personal data are processed by the DC for the purpose of performing and settling agreements related respectively to the design/production/distribution/servicing of Kamet products and the rights/obligations arising therefrom, including pursuing claims or marketing the DC's own products and services, i.e. pursuant to Article 6(1)(b), (c), or (f) of the GDPR;
2. first name, last name, company name, position (function) and contact details (mailing address, email address, telephone and fax numbers) of representatives of the DC's contractors and suppliers, which data were obtained when entering into or performing agreements related respectively to the design/production/distribution/servicing of Kamet products, for the purpose of establishing contact in connection with offering, concluding, and performing such agreements and the rights/obligations arising therefrom, including pursuing claims or marketing the DC's own products and services, i.e. pursuant to Article 6(1)(b) or (f) of the GDPR.

Personal data are processed only for the period necessary to achieve the purposes of processing and will be deleted from the DC's databases promptly after processing for the above-mentioned purposes has been completed, no later than upon the expiry of limitation periods for obligations arising from the aforementioned agreements.

Your personal data may be transferred, for the purposes specified above, to Kamet Inwestycje S.A. with its registered office in Reńska Wieś (KRS: 0000697043) and to the DC's subcontractors, such as IT service providers of the software used by the DC and other service providers rendering services related or subordinate to the design/production/distribution/servicing of Kamet products, as well as services related to settlement of the above-mentioned agreements, delivery and courier companies, companies providing professional document disposal services, insurance companies, accounting firms, banks, and legal and economic auditors. Processing of personal data is necessary to offer a transaction, perform it, or settle it. The DC does not apply automated decision-making or profiling with regard to you.

You have the right to request that the DC ensures easy access to your personal data, to rectify them, erase them, or restrict their processing, as well as the right to object to their processing and the right to data portability. You also have the right to lodge a complaint with the competent supervisory authority responsible for personal data protection.
